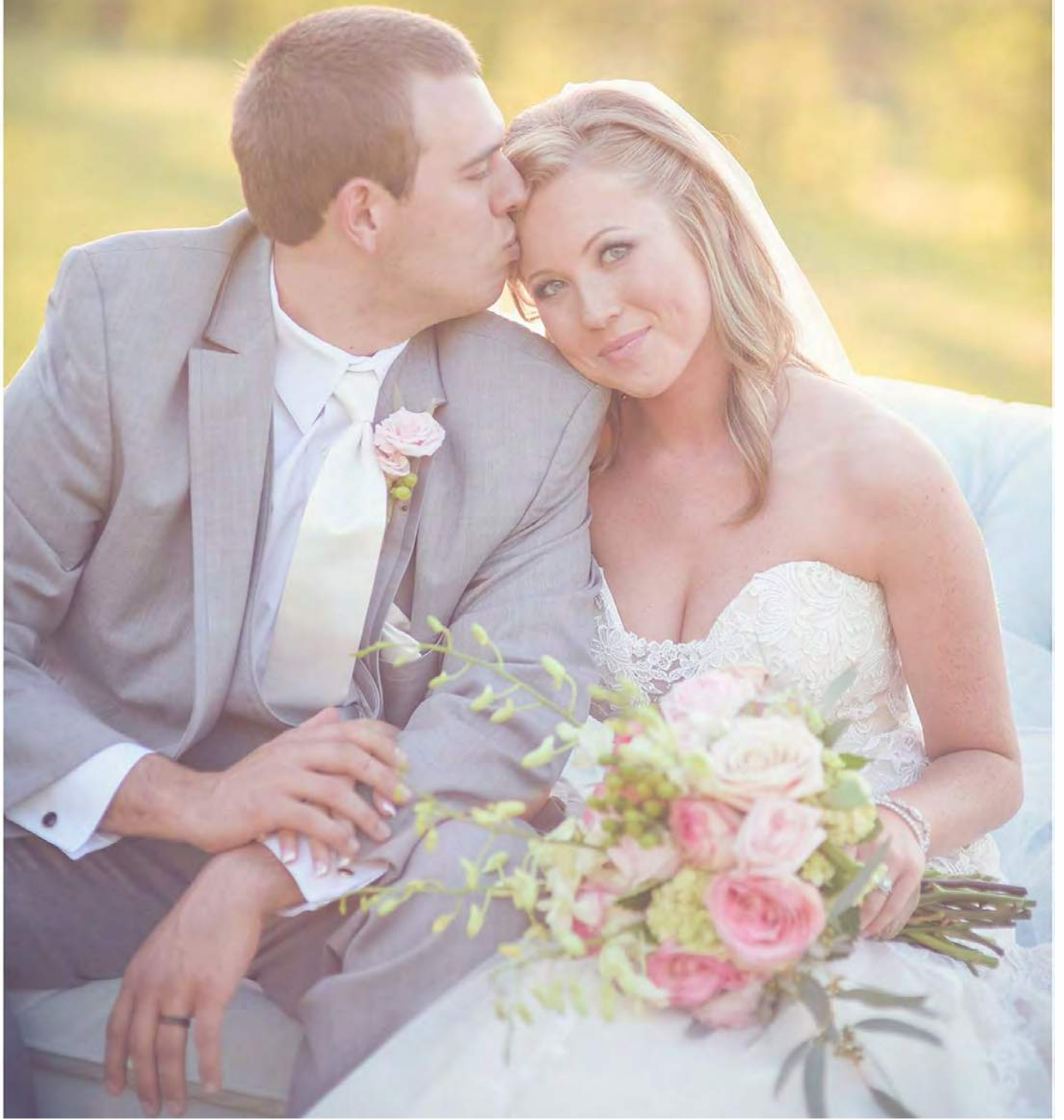

The photos we take are one of the only things you will physically have to look back on from your wedding.

FOR MY WEDDING PACKAGES, I BASICALLY CUSTOMIZE THEM ACCORDING TO THE COUPLE'S WISHES, NEEDS, AND BUDGET. LISTED BELOW IS A BASIC PACKAGE. WE CAN BUILD ONTO THE PACKAGE OR REMOVE IF NEEDED.

BASIC WEDDING PACKAGE:

- SIX HOURS OF WEDDING COVERAGE
(INCLUDES BRIDAL PARTY GETTING READY,
DECOR, CEREMONY, RECEPTION, ETC.) = \$700
 - ASSISTANT SECOND SHOOTER FOR CEREMONY AND RECEPTION = \$100
(SECOND SHOOTER ENSURES ALL ANGLES ARE
COVERED AND NOT A MOMENT IS MISSED)
 - COPYRIGHT RELEASE GALLERY INCLUDING ALL EDITED IMAGES = \$700
- *WITH THIS GALLERY, YOU MAY PRINT ANY QUANTITY DESIRED OR SIZE
DESIRED UP TO 8X10. IMAGES LARGER THAN 8X10 MUST BE
ORDERED THROUGH THE PHOTOGRAPHER.

TOTAL = \$1500

ENGAGEMENT SESSIONS:

A FULL SESSION INCLUDES YOUR SESSION TIME, WHICH IS APPROXIMATELY ONE HOUR, AND MULTIPLE OUTFITS IF DESIRED. ONCE SESSION IS COMPLETE, IMAGES ARE PROOFED AND EDITED. THEN ALL OF YOUR EDITED IMAGES ARE GIVEN TO YOU IN A COPYRIGHT RELEASE GALLERY WITH 35-40 IMAGES. THIS GALLERY IS SUITABLE FOR PRINTING ANY QUANTITY DESIRED AND UP TO 8X10. FOR PRINTS LARGER THAN 8X10, YOU WOULD ORDER THROUGH PHOTOGRAPHER.

TERMS AND CONDITIONS

Deposit and Payment: A minimum retainer of \$200 is required when wedding date is booked by the client. The remaining balance is due *the week of* the wedding. All deposits are nonrefundable, in the event of a date change or wedding cancellation by the client for any reason.

Cancellation: If Photographer is unable to perform to the specifications of this contract due to a fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographer's illness, then the Photographer shall return the deposit to the Client but shall have no further liability with respect to the Agreement. If Alea Kent Photography is unable to perform to the obligations in this contract for reasons outside the sole control of Alea Kent, she will not be liable for costs in excess of the amount the client has paid. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost through computer malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the photographer, Alea Kent.

Negatives and/or Files: Digital high resolution negatives will be given to the client, along with a copyright release so that client can print their enlargements when and where they choose.

Exclusive Photographer: The photographer will be the exclusive photographer retained by Client to photograph the wedding; excluding other professionals and amateurs. Family and friends of the Client are permitted to take photographs as long as they do not interfere with the Photographer's duties and do not take images of poses arranged by Photographer.

Photographs: Although great care will be taken with the negatives and/or files taken at the wedding, Photographer limits any liability for loss, damage or failure to deliver pictures for any reason to return of all deposits made.

Model Release: Photographs taken by the Photographer may be used for the purpose of display, portfolio, advertising, website or any publication to promote his/her studio or name, and the images can be used without additional compensation to the undersigned.
